

Dear Association for the Protection of Human Rights,

I address you as an institution that serves to correct and maintain human rights, which are valid in the various conventions listed below as an agreement of all member states, including Austria.

The situation of unvaccinated and healthy people in Austria can be assigned to torture that is prohibited by international law. These unvaccinated but healthy people have been in permanent lockdown since November 2021. They are thus an ethnic group that has been marginalized through isolation.

Corona is a disease that includes easily classifiable risk groups: only older people, at least over 60, with one or more previous illnesses, obesity and diabetes mellitus belong to this group, the course of which could be severe or even fatal in a few cases. The mortality rate from COVID-19 is worldwide: 0.15% according to Dr. Ioannidis<sup>1</sup>, although it remains unclear what these people actually died of. There were autopsies done only in the per mil range.

Prophylaxis should be seen as the mildest remedy; this is not propagated in Austria. Therapy that is successfully used in many parts of the world is prohibited in Austria. The purchase of ivermectin on the Internet will be identified and punished by government. In Austria, after a positive test (which alone is insufficient), you are sent into quarantine without the possibility of therapy or information. One has to wait and see how the disease develops.

On January 7<sup>th</sup> 2022 there were 289 cases in intensive care, but it is unknown whether these patients suffer from or with Covid, whether they are vaccinated or counted as unvaccinated. The available capacities were never fully utilized during the entire time of the so called pandemic. Vaccination that is older than 6 months is declared invalid, one is not vaccinated. A single vaccination is considered unvaccinated. From now on, two vaccinations older than 6 months, are also considered not to have been vaccinated because they have to be boosted. The convalescent status is only valid for 180 days, and then one is considered unvaccinated.

FFP2 masks, which according to the WHO have no influence whatsoever on infection, must also be worn outdoors.

Keep a distance of 2 meters to other people.

The arbitrary shortening of the duration of the green pass (1 year to 6 months) adds over 3 million people to the unvaccinated.

Recent governments instructions: "From January 11<sup>th</sup>, 2022, an FFP2 mask will also apply outdoors if the 2-meter distance cannot be maintained. This applies to pedestrian zones, queues, and group gatherings, for example. The obligation to wear does not apply to close relatives such as partners or children. The validity of the Green Pass will be reduced to 6 months from February 1st. Commerce and body-hugging services."

The nationwide general lockdown ended on December 12<sup>th</sup>, 2021. For people without valid 2G (entirely vaccinated or recovered) proof, the exit restrictions remain in place (lockdown for unvaccinated people).

Retail and body-related services are open to people with valid 2G proof.

Which rules apply to private meetings?

Vaccinated and convalescents are allowed to meet a maximum of 25 people between 5 a.m. and 10 p.m. After 10 p.m., only gatherings of no more than 10 people from different households are allowed.

The PCR test used is not a diagnostic tool that can be used to identify corona viruses, but this test is used as an indicator for infections. Statements from about replication cycle 25 are no longer reliable, with the present PCR test up to about 45 replication cycles are run through. "The corona pandemic exists in particular due to the high number of infections. This means the numbers of positive test results. The infection numbers do not indicate how many people are sick, they do not indicate how many are in bed or even in hospital with symptoms. On the contrary, most people with a positive test result are doing quite well, and many are completely symptom-free. So if the PCR test didn't exist, we would most likely not have a pandemic."<sup>3</sup>

"Vaccination does not provide sterile immunity.

Two weeks after vaccination one is still considered to be unvaccinated, since naturally most of the side effects occur within the first two weeks after application.

People who are just once vaccinated are considered as unvaccinated.

On average, over 50% of intensive care patients are vaccinated.

There is no statistically significant relationship between the vaccination rate, infection rate and mortality.

Lockdowns are unsuitable and disproportionate, they do not prevent the spread of a disease, on the contrary, in Austria the infection rate is significantly higher than in Sweden, for example, and mortality is up to 40 times higher.

The vaccination in no way reduces contagion - or the risk of mortality, the probability of NOT ending up in the intensive care unit as an unvaccinated person was 99.52%, as a vaccinated person it was 99.92%."<sup>4</sup> <sup>5</sup>

Insults and humiliations, which have been made publicly in politics several times, serve to intimidate the population, who are unvaccinated and healthy: Quote from Kogler: "State objectors, enemies of democracy, neo-Nazis and neo-fascists".

Those who do not get vaccinated are threatened with loss of work and loss of income, thus depriving their livelihood. Resignations have already been issued en masse.

Doctors and nursing staff are put under pressure, prevented from practicing their profession by means of disciplinary procedures on the part of the representative chamber, terminated and silenced. Brochures and ordination posters are prepared as pre-printed forms to promote vaccinations. Doctors are prohibited from being critical when threatened with disciplinary proceedings comment on the vaccination or advice against it to patients who experience health problems as a result.<sup>6</sup>

The information about the risks and side effects of the vaccines has been outsourced, the questionnaires are written differently depending on the federal state. The first sheet relates to study data that is collected; the second sheet does not state that mRNA vaccinations can be fatal. Hundreds of athletes worldwide have died of heart failure, many people will follow, and

their genetics have been modified, although the risk of COVID disease would have been below 0%. 957k people suffered injuries or death from covid-19 vaccinations.<sup>7</sup>

All of this, all “measures”, accompanying or directly imposed, are deliberately illegal and culpable; over 30 “measures” by the government were - in retrospect - designated as unconstitutional and repealed.

The government's ordinances against its own people fulfil this requirement severe coercion, marginalization and torture. There is also no reason for the planned enforcement of mandatory vaccination.<sup>8</sup>

I am now referring to the European Convention on Human Rights

Art. 3: Prohibition of torture: Nobody may be subjected to torture or inhuman or degrading punishment or treatment.

Exclusion and isolation through permanent lockdowns of healthy groups of people or individuals constitute torture.

Public insults by politicians against healthy groups of people or individuals qualify as degrading treatment.

Art. 5: Right to freedom and security

(1) 1: Everyone has the right to liberty and security. 2: Freedom may only be withdrawn in the following cases and only in the manner prescribed by law:

e) Lawful deprivation of liberty with the aim of preventing the spread of infectious diseases, as well as in the case of the mentally ill, alcohol or drug addicts and vagabonds;

It has been established that lockdowns are ineffective in preventing the spread of infectious diseases. Rather, they fulfil the condition of severe coercion, namely to be forced to an ineffective but harmful vaccination in order to be able to participate in public life again.

Thus Article 5 (5) comes into force, because every form of isolation is deprivation of liberty and torture, so that everyone affected by it has the right and the right to compensation.

Art 7: No punishment without law: As more than 30 government ordinances have been unconstitutional so far, I refer to Art. 7 (1) 1 Nobody may be convicted of an act or omission that at the time of its commission under domestic or international law was not punishable.

Art. 8: Right to respect for private and family life

(1) Everyone has the right to respect for their private and family life, their home and their correspondence. The Austrian government also violates this article because, quote:

“Vaccinated and convalescents are allowed to meet a maximum of 25 people between 5 a.m. and 10 p.m. After 10 p.m., only gatherings of no more than 10 people from different households are allowed. The lockdown continues to apply to unvaccinated people.” Thus, unvaccinated healthy people have continued to be excluded not only from public life but also from their own private and family life since November 2021.

Art. 9: Freedom of thought, conscience and religion

(1) Everyone has the right to freedom of thought, conscience and religion; this right includes the freedom to change one's religion or belief and the freedom to profess one's religion or

belief individually or jointly with others, publicly or privately, through worship, teaching, or the practice of customs and rites.

(2) The freedom to profess one's religion or belief may only be subject to restrictions that are provided for by law and are necessary in a democratic society for public security, for the protection of public order, health or morality or for the protection of rights and freedoms of another.

It is pointed out here that scientific discourse by respected and recognized experts is forbidden by so-called experts, in that germanists and journalists or completely inadequately trained and paid persons determine which content can be deleted and which can be disseminated. Dr. Robert Malone, who was crucial in the invention of the mRNA vaccine, has been banned from Twitter.<sup>9</sup> This has nothing to do with public interests, because it is in the public interest to be able to weigh up all advantages and disadvantages before making a decision. The mRNA or vector vaccines are temporarily emergency-approved and it has been proven that they can cause serious side effects up to death. By concealing, falsifying and manipulating numbers or by hiding the terms that are important for statistics, groups of people and individuals are misled; they are deceived and manipulatively forced to consent to medical interventions (repeated vaccinations).

Thus, the right to freedom of expression according to Art. 10 is not only curtailed, but manipulated on one side, making it impossible to get a neutral but complete picture of the situation.

(1) Every person has the right to freedom of expression. (2) This right includes freedom of expression and the freedom to receive and pass on information and ideas without official interference and regardless of national borders. (3) This article does not prevent states from requiring approval for radio, television or cinema companies.

It would be important to start taking responsibility on all platforms on the Internet, because the obfuscation, concealment and concealment and manipulation of important data on public health endangers national security, territorial integrity or public security, and the maintenance of order is prevented, the perpetration of crimes by desperate and isolated citizens is encouraged, the protection of health or morality is unilaterally abolished, the protection of the good reputation or the rights of others is subjected to inadequate correction and public insults on the part of politicians.

The impartiality of the jurisprudence is abolished. The boundaries between legislative and executive are abolished with the supremacy of the Federal Minister for SGPK.

Art. 11: Freedom of assembly and association

(1) Everyone has the right to freely and peacefully assemble with others and to associate freely with others; this includes the right to form and join unions to protect one's interests.

(2) (1) The exercise of these rights may only be subject to restrictions that are provided by law and are necessary in a democratic society for national or public security, for maintaining order or for preventing criminal offenses, for protecting health or morals or for protection the rights and freedoms of others. (2) This article does not prevent lawful restrictions on the exercise of these rights by members of the armed forces, police or state administration.

This article has also already been violated to the extent that attempts are made to portray the demonstrators publicly as objectors to the state, enemies of democracy, neo-Nazis and neo-fascists, to subject them to arbitrary masking obligations and to punish them under administrative law for non-compliance. Maintaining a distance of 2 meters is simply not

possible in a demonstration march of about 500,000 people. Thus, the Austrian government is also violating these people's rights.

The right to demonstrate is in principle inviolable in a democracy.

Art. 13: Right to an effective complaint: Any person who has been violated in their rights or freedoms recognized in this Convention has the right to lodge an effective complaint with a domestic authority, even if the violation has been committed by persons who acted in an official capacity.

Complaints can be lodged, but the length of time it takes to pass resolutions is totally inadequate for the damage caused by government measures imposed. Thus, the effectiveness of a complaint is simply not given.

Art. 14: Prohibition of discrimination: The enjoyment of the rights and freedoms recognized in this Convention is without discrimination, in particular because of gender, race, skin color, language, religion, political or other opinion, national or social origin, and affiliation to ensure a national minority, property, birth or any other status.

This is already violated by the fact that healthy groups of people are in permanent lockdown. To describe them as objectors to the state, enemies of democracy, neo-Nazis and neo-fascists is humiliating and intended to demotivate.

Art. 15: Deviation in case of emergency

(1) If the life of the nation is threatened by war or another state of public emergency, each High Contracting Party may take measures which deviate from the obligations provided for in this Convention, but only to the extent that the situation absolutely requires it and if the measures are not in accordance with the present Convention Contradict the other obligations of the contracting party under international law.

(2) On the basis of paragraph 1, Article 2 may only be deviated from in the case of deaths as a result of lawful acts of war and Article 3, Article 4 (paragraph 1) and Article 7 in no case.

(3) 1Each High Contracting Party which exercises this right of deviation shall fully inform the Secretary General of the Council of Europe of the measures taken and the reasons for them.

2It shall also inform the Secretary General of the Council of Europe of the date on which these measures have expired and the Convention will again apply in full.

It should be said that during the entire so-called pandemic, the available intensive care beds were never fully utilized. The state of a pandemic or a possible emergency was never even remotely reached. The number of coronavirus infections is similar to that of the annual flu wave, and people suffering from flu are counted among those infected with corona, as the PCR test does not differentiate between them.

The government's arbitrarily chosen measures have never been appropriate or the slightest measure, on the contrary, every effort will be made to achieve a vaccination rate above 90%, even if it is not evidence-based or science-based or makes any sense.

The mandatory vaccination procedure was chosen for the last time by Adolf Hitler when he passed the law to combat black smallpox. Since this included completely different mortality rates, as well as the stability of the virus and, above all, the effectiveness of the inoculated harmless cowpox, this can be done with a serum that interferes with the human DNA but has no effect against infection, but is forced, which has more side effects than all vaccinations related to human history, not to be equated.

The inoculated mRNA or vector based vaccines are not protective vaccinations.

Torture (also torture or torture) is the targeted infliction of psychological or physical suffering (pain, fear, massive humiliation) in order to blackmail statements, to break the will of the torture victim or to humiliate the victim.

## § 312a StGB Torture

Torture is the deliberate infliction of severe pain or suffering on a person.

Torture has been carried out or sanctioned by individuals, groups, and states throughout history from ancient times to modern day, and forms of torture can vary greatly in duration from only a few minutes to several days or longer. Reasons for torture can include punishment, revenge, extortion, persuasion, political re-education, deterrence, coercion of the victim or a third party, interrogation to extract information or a confession irrespective of whether it is false, or simply the sadistic gratification of those carrying out or observing the torture. [1]

The permanent lockdowns of unvaccinated people are designed to break their resistance to vaccination with mRNA or vector vaccines. The lockdowns are designed to publicly discriminate and discredit those who do not want to be vaccinated by holding them responsible for spreading the virus and illnesses other people. This is not evidence based. This is arbitrary psychological torture. Furthermore, you ruin any financial existence with permanent lockdowns.

I also refer to the UN AGREEMENT AGAINST TORTURE<sup>10</sup>

"Nobody should be subjected to torture or cruel, inhuman or degrading treatment or punishment." (Article 5)

«Nobody should be subjected to torture or cruel, inhuman or degrading treatment or punishment. In particular, nobody may be subjected to medical or scientific experiments without their voluntary consent. " (Article 7)

"Everyone who has been deprived of his or her freedom must be treated humanely and with respect for the dignity inherent in human beings." (Article 10)

UN Declaration on the Protection of All Persons from Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (1975) "No state may allow torture or other cruel, inhuman or degrading treatment or punishment." «... For this purpose, the following are and remain forbidden in relation to the above-mentioned persons at any time and anywhere:

a) Attacks on life and limb, in particular murder of any kind, mutilation, cruel treatment and torture

c) Impairment of personal dignity, in particular degrading and degrading treatment »(Article 3 of the Universal Declaration)

I see all of these articles and agreements violated by the constant solitary confinement of healthy people, their degradation through public insults, furthermore the placing of the question of guilt on unvaccinated people who are not responsible for the spread of the corona virus. On the contrary, it is the vaccinated that create and spread further disease spots through breakthroughs in the vaccination, here is just one example.<sup>11</sup> Likewise, it is the vaccinated that fill the hospitals.<sup>12</sup>

Statutes of Amnesty International Austria<sup>13</sup>

Article 3 (Aims and Purpose of the Association) Amnesty International's vision is that of a world in which all people have the rights enshrined in the Universal Declaration of Human Rights and other international human rights standards. In order to achieve this goal, Amnesty International has set itself the task of preventing or ending serious violations of these rights through investigative work and actions. I urge you as an organization, in accordance with your statutes to uphold the conventions relating to human rights, to take action and the Austrian government to immediately end all measures, immediately end any attempt at further psychological torture, coercion and extortion on unvaccinated groups of people and the cessation of all vaccinations and finally stopping the implementation of appropriate prophylaxis and therapy.
